Which of your personal data do we process and for what purposes?

First and last name, address, landline and mobile phone number, e-mail address, bank details if applicable, tax number, tax ID, VAT ID.

We will only process this data for the purposes for which we received or collected it.

Data processing for other purposes can only be considered if the legal requirements necessary in this respect pursuant to Art. 6 (4) DSGVO exist. In this case, we will of course comply with any information obligations pursuant to Art. 13 (3) DSGVO.

On what legal basis is the processing based?

The legal basis for the processing of personal data is generally - unless there are other specific legal provisions - Art. 6 DSGVO. The following possibilities in particular come into consideration here:

- Consent (Art. 6 para. 1 p. 1 lit. a) DSGVO)
- Data processing for the fulfilment of contracts (Art. 6 para. 1 p. 1 lit. b) DSGVO)
- Data processing for the fulfilment of a legal obligation (Art. 6 para. 1 p. 1 lit. c) DSGVO)
- Data processing on the basis of a balancing of interests (Art. 6 para. 1 p. 1 lit. f) DSGVO)

If personal data is processed on the basis of your consent, you have the right to revoke your consent at any time with effect for the future.

If we process data on the basis of a balance of interests, you as the data subject have the right to object to the processing of the personal data, taking into account the requirements of Art. 21 DSGVO.

To which recipients will your data be passed on?

Your personal data will only be passed on to third parties if this is necessary for the performance of the contract with you, if the transfer is permissible on the basis of a consideration of interests in accordance with Art. 6 Para. 1 Sentence 1 lit. f) DSGVO, if we are legally obliged to do so, or if we have the right to do so.
